Rally entry total includes all AKC fees: First entry/additional entry \$3.00/\$3.00.

Entry Method and Payment Options:

- **USPS Mail -- Completed and Signed Entry Form accompanied by a Check or Money Order made out to TMDTC and mailed to the Trial Secretary.**
- **EMAIL -- Completed and Signed PDF Entry Form emailed to the Trial Secretary at TMDTC.Obedience@gmail . Emailed entries may be paid via PayPal to TMDTC.Obedience@gmail.com In the Comments section please refer to the Owner name on the entry form, so the paperwork can easily be matched. The entrant must pay all applicable PayPal fees (use the Friends/Family payment option).**
- ***Entries where the PayPal fees have been charged to the club will not be accepted.***

ENTRIES open Wednesday, May 17, 2023 at 8 am (PST). Due to limited entries, they must be mailed (e-mailed or physically-mailed) to the secretary's address. No entry will be accepted before the opening date and time. If your entry arrives before the opening date/time you will be notified, and the entry will be shredded. You will be allowed to send another entry. No entries will be accepted by phone or fax. Express mail entries must include the signature waiver allowing them to be left at the secretary's address. Hand delivered entries will be accepted in the designated location at the TMDTC Clubhouse.

CLOSING DATE FOR ENTRIES: 12:00 PM (NOON) Wednesday, June 28, 2023 OR when the maximum entry has been reached, after which no entries may be accepted, canceled or changed.

NOTICE TO EXHIBITORS

TELEPHONE, FAXED, UNSIGNED or INCOMPLETE ENTRIES cannot be accepted. Entries not on official AKC Entry Forms & photocopies of entry forms without the Agreement and Rules on the reverse side of the Official AKC Entry Form are NOT ACCEPTABLE. Incomplete includes failure to insert jump height in a class requiring it.

No Entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. Postdated checks and returned checks do not constitute a valid entry fee.

Acknowledgment of receipt of entries will be made soon after the closing date. The club assumes no responsibility for a wrong entry.

How To Use The Entry Blank: Use one entry blank per dog only if information is exactly the same for each day. Carefully check the box for each show in which you wish to enter your dog. A separate form should be used if the same dog is entered in different classes on different days. The boxes indicating the shows you wish to enter must be checked. Please TYPE or PRINT all information on entry forms. OBEDIENCE AND RALLY HAVE DIFFERENT ENTRY FORMS

Entry Fees shall not be refunded in the event that a dog is absent, disqualified, excused by Judge, or barred from competition by action of Show Committee. If because of riots, civil disturbances, venue contract cancellation or other acts beyond the control of the management it is impossible to open or complete the show, no refund of entry fee will be made. The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the show before completion, no refund of entry will be made.

Refunds for bitches in season will be given less \$5.00 for administrative fees. Written notice must be given to the Trial Secretary at least 30 minutes before judging starts.
Full refund for bitches in season if trial secretary is notified before the Monday preceding the event.

Transfers will be permitted in accordance with Chapter 1, Section 16a of the Obedience Regulations. Please notify the Trial Secretary in writing as soon as possible, but at least 30 minutes prior to start of that day's judging. (before 8AM)

Once again TMDTC will be offering a raffle each day. Our Raffle Committee works hard to create over 30 baskets offered each day, in addition to select special items.

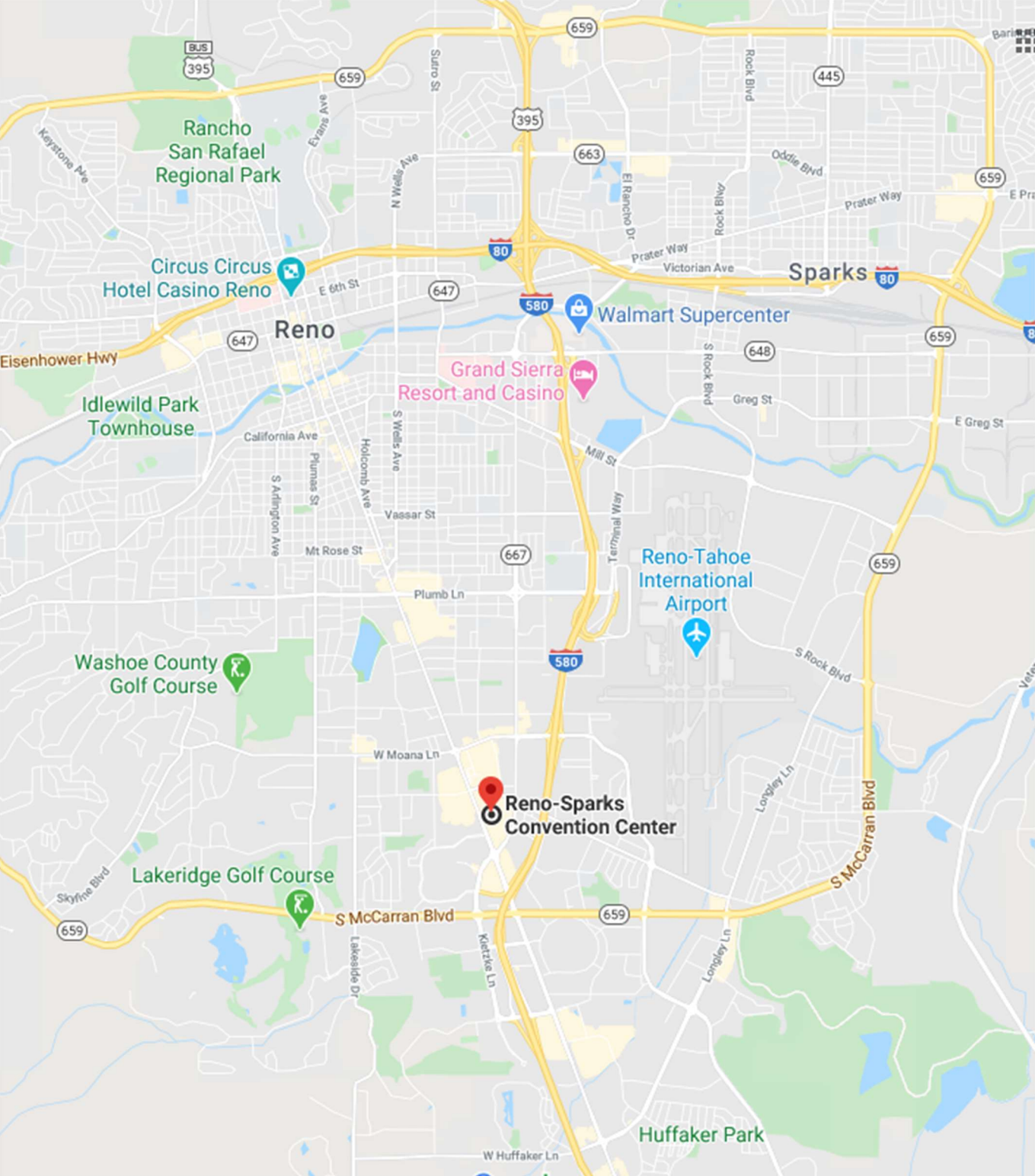
Each day, there is also a drawing for a Consolation Basket. If you NQ, put your name on the back of your armband and put it in the drawing for that prize. Drawing is pulled at the end of the day after the last classes are judged.



ADDITIONAL TRIAL RULES

- No set up for exhibitors before 12 noon on Thursday July 13, 2023.
- Dogs must be kept on leash except when in the ring or when in a designated warm-up area.
- NO FLEXI LEADS. Dogs may be on a 6' leash or shorter outside the ring or in the potty area.
- There shall be NO drilling nor intensive or corrective training of dogs on the show grounds or premises.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.
- Consult Judging Program for time of judging. Exhibitors are responsible for having their dogs at ringside when it is their turn to be judged.
- Dogs not required for further judging may be excused after their class has been judged.
- In case of a tie for any prize, any dog that is not present for a run-off will forfeit its rights to the prize.
- No Award will be mailed or delivered.
- *Day crating space is limited – please be considerate and take a minimum footprint.*
