

### **Entry Method and Payment Options:**

**ENTRIES open May 22, 2025, at 8 am (PST).** Due to limited entries, they must be mailed (emailed or physically mailed) to the secretary's address. No entry will be accepted before the opening date and time. If your entry arrives before the opening date/time you will be notified, and the entry will be shredded. You will be allowed to send another entry. No entries will be accepted by phone or fax. Express mail entries must include a signature waiver allowing them to be left at the secretary's address. Hand delivered entries will be accepted in the designated location at the TMDTC Clubhouse.

**CLOSING DATE FOR ENTRIES: 6:00 PM, June 26, 2025,** OR when the maximum entry has been reached, after which no entries may be accepted, canceled or changed. If maximum entry is reached, a waiting list will be maintained.

#### **NOTICE TO EXHIBITORS**

TELEPHONE, FAXED, UNSIGNED or INCOMPLETE ENTRIES cannot be accepted. Entries not on official AKC Entry Forms & photocopies of entry forms without the Agreement and Rules on the reverse side of the Official AKC Entry Form are NOT ACCEPTABLE. Incomplete includes failure to insert jump height in a class requiring it. Also Designate A or B in the appropriate classes.

No Entry shall be made, and no entry shall be accepted, which specifies any conditions as to its acceptance. Postdated checks and returned checks do not constitute a valid entry fee.

How To Use Entry Blank: Use one entry blank per dog only if information is the same for each day. Carefully check the box for each show in which you wish to enter your dog. A separate form should be used if the same dog is entered in different classes on different days. The boxes indicating the shows you wish to enter must be checked. Please TYPE or PRINT all information on entry forms.

Entry Fees shall not be refunded if a dog is absent, disqualified, excused by Judge, or barred from competition by action of Show Committee. If, because of riots, civil disturbances, venue contract cancellation or other acts beyond the control of the management it is impossible to open or complete the show, no refund of the entry fee will be made. The well-being of dogs, exhibitors and spectators is of paramount importance, and, in the event, it is necessary to cancel or stop the show before completion, no refund of entry will be made.

Refunds for bitches in season will be given less \$10.00 for administrative fees. Written notice must be given to the Trial Secretary at least 30 minutes before judging starts. Full refund for bitches in season if trial secretary is notified before the Monday preceding the event.

Transfers will be permitted in accordance with Chapter 1, Section 16a of the Obedience Regulations. Please notify the Trial Secretary in writing as soon as possible, **but at least 30 minutes prior to the start of that day's judging. (before 7:30 AM)** 





## Raffle




TMDTC will be offering a raffle. Our Raffle Committee works hard to create fun baskets in addition to select special items.

#### **ADDITIONAL TRIAL RULES**

- Set up for exhibitors starts at 7am on Friday, July 11<sup>th</sup>.
- Dogs must be kept on leash except when in the ring.
- NO FLEXI LEADS. Dogs may be on a 6' leash or shorter outside the ring or in the potty area.
- There shall be NO drilling nor intensive or corrective training of dogs on the show grounds or premises.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such a case, no refund of any fees paid will be made.
- Consult Judging Program for time of judging. Exhibitors are responsible for having their dogs at ringside when it is their turn to be judged.
- Dogs not required for further judging may be excused after their class has been judged.
- In case of a tie for any prize, any dog that is not present for a run-off will forfeit its rights to the prize.
- No Award will be mailed or delivered.
- Day crating space is limited please be considerate and take a minimum footprint to accommodate your dogs and gear. A 4x4 expen to accommodate two St. Bernards is fine; an 4x4 expen to accommodate one chihuahua is not.
